Everything Applicant stated on this application is correct to the best of its knowledge. Applicant understands that Hed Cycling Products, Inc. (HED) may retain this application whether or not it is approved. HED is authorized to check Applicant's/Customer's credit history and to provide information about HED credit experience with Customer. Customer must submit financial statements within 90 days of each fiscal year-end to keep this Application current. Name changes or business structure changes may require a new application. Any decision with the respect to the extension or continuation of credit availability shall be at the sole discretion of HED and HED may terminate any credit availability at any time within its sole discretion. It is understood and agreed that this Application will be used in connection with sales made by HED. Customer agrees to pay the entire debt that customer shall incur on any HED account which may be granted to customer plus all collection costs and attorney fees, plus any finance charge with may be imposed in accordance with the terms of the HED credit agreement which is set forth below and is made a part hereof. **PAYMENT TERMS**

The terms of this sale are listed on each invoice. Payments must be received on or before the invoice due date. Invoices will be paid from your selected bank account by Electronic Funds Transfer (EFT). If the due date falls on a Saturday, Sunday or a bank Holiday, we will transfer the funds on the next banking day. Notwithstanding any of the above, in the event that a sale was made to a Customer in reliance on any misrepresentation made by such Customer, the amount owing from such sale is due immediately upon demand by HED.

**LATE PAYMENT FINANCE CHARGES**

Invoices not paid in accordance with the payment terms will be considered overdue. Finance charges will be assessed at an annual rate of 18% or the maximum allowable rate by state law, whichever is greater, on overdue invoices until payment is received by HED. HED may adjust the applicable finance rate upon thirty (30) days notice to applicant, and applicant agrees to be bound by such modification. The applicable finance rate will appear on the invoice if it differs from 18%.

**MAINTENANCE OF CREDIT PRIVILEGES**

Customers that have invoices overdue are subject to having credit privileges removed and being placed on COD terms. We may delay enforcing our rights under this agreement without losing them. We may accept late payments, partial payments, checks and money orders marked as being payments "in full" without losing any of our rights under this agreement.
